



Internet Governance **Forum Events**

As the Internet evolves rapidly, so do the laws and policies that govern it. Without collaborative knowledge exchange and multistakeholder convenings to discuss these changes, the decisions about the laws and policies which affect many risk falling into the hands of few.

Since mid-2021, the Internet Society Foundation has been running a standalone Internet Governance Forum (IGF) Event Sponsorship program with the goal of encouraging open and inclusive multi-stakeholder dialogues on Internet policy issues at national and regional levels around the world. Through this program, funding is available to IGF Secretariatrecognized National and Regional Initiatives (NRIs) as well as National and Regional Schools on Internet Governance (SIGs).

Impact:

2023 was the second full year that the Internet Society Foundation administered this program and the first year the full budget was disbursed. The Foundation sponsored 16 National IGFs globally, making this our most frequently funded event type.



Enhanced Reporting for Understanding Impact

Thanks to strategic revisions to our sponsorship application and reporting forms, we've been able to collect meaningful data about NRIs and SIGs on issues that matter such as inequality.

This data can easily be aggregated and shared with the broader community which aims to promote the multistakeholder model of Internet Governance. As a prominent funder in this space, we are uniquely poised to contribute to discussions on the impact that these events have at a high level. In next year's report, we will further explore trends in participation, including aggregated stakeholder group and gender participation across regions and events.

Reach

Our 2023 sponsorship recipients collectively engaged 6,100 participants in their events and produced 629 graduates of National and Regional Schools on Internet Governance.

Supporting Applied Learning


We proudly support a diverse array of Schools which continue to evolve and pursue innovative and engaging approaches. Some schools have had their students develop and publish influential documents, including:

- <u>Guidelines to inclusive, multistakeholder</u> implementation of the African Union Data Policy Framework - developed by the 2023 AfriSIG Fellows
- Follow-up Statement on the Global Digital <u>Compact</u> – developed by the 2023 **EuroSSIG** Fellows
- Privacy, Digital Rights, and Human Rights <u>Issues & Towards a Secure and Inclusive</u> <u>Digital Future for Nigeria</u> – developed by the 2023 Nigeria SIG Fellows

In Latin America, we additionally supported the 6th edition of the Diploma en Gobernanza de Internet and the 15th South School on Internet Governance, both of which offer participants pathways to formal university diplomas in Internet Governance.

Inaugural Youth IGF -Democratic Republic of Congo

As a leading funder in the field, our program offers critical support to new or growing NRIs when it matters most. In 2023, we sponsored the inaugural Youth IGF Democratic Republic of Congo (YIGF DRC), organized by one of Internet Society's 2023 Youth Ambassadors and in collaboration with the Internet Society DRC Chapter. This new forum facilitated productive discussions between representatives of all stakeholder groups as well as meaningful engagement between youth and the national telecommunications regulator. As a result of their participation, representatives of the regulator agency (ARPTC) underscored the need for further discussions to prevent abuse of the Internet during elections and called for follow-up multistakeholder meetings to address them.



Bosnia and Herzegovina IGF

Another one of our 2023 sponsorships supported the relaunch of the Bosnia and Herzegovina IGF (BH IGF) following a 5-year period of inactivity. In response to rapid developments in technology and legislation which holds important ramifications for human rights, the Balkan Investigative reporting Network Bosnia & Herzegovina (BIRN BH) led the reformation of the BH IGF to facilitate multistakeholder discussions of these issues. Their 2023 forum subsequently gathered 110 participants representing all stakeholder groups, garnered significant local media coverage, and led to plans to develop a local School on Internet Governance.
