##### Recommended:

- Any other relevant documents such as financial or operational plans for the project, network diagrams, recent annual reports, feasibility studies, consultations with communities, quotes for services or equipment etc.
- Letters of Support: if you are partnering with other organization(s) to implement any part of your project, attach letters, agreements, Memoranda of Understanding, or other relevant documents that demonstrate your partnership.

#### Organization Documents



Required:

- Tax Identification Document(s): organizational tax documents that demonstrate your organization's non-profit/charitable status
- Governing Document(s): such as Articles of Incorporation or Charter documents
- Financial Documents: Current organizational budget, latest audits or national tax returns within the last two years

Recommended:

- Equivalency Determination: A certification that your organization is equivalent to a U.S. 501c3 public charity. Include only if you already have one and it is current.
